Description of  
C.F. Wilmot's addition to the City of Ann Arbor, Beginning on the north & South quarter-lots of Section 28, Township 36<sup>th</sup> South Range 3<sup>rd</sup> East State of Michigan at the center of the Yeddes Road (so called) thence South 88<sup>th</sup> degrees East along the center of said road three chains & thirty links to the West side of Elm Street, thence South sixteen degrees West nine chains & thirty three links to a corner by iron bar & stone north 88<sup>th</sup> degrees four degrees West nine chains & thirty eight links thence South thirty seven degrees West seven chains & thirty links to the center of Washtenaw Avenue, thence north 113<sup>th</sup> degrees West along the center of said Washtenaw Avenue, thence chains & sixty three links to the center of Cemetery Street, thence north 88<sup>th</sup> degrees & 30 minutes East along the center of Cemetery Street to the center of the aforesaid Yeddes road thence South sixty eight degrees East to the place of beginning. Excepting from the above lots numbers 18, 19, 29 & 30 on the annexed plat which have been heretofore sold but plotted by request of the owners.
