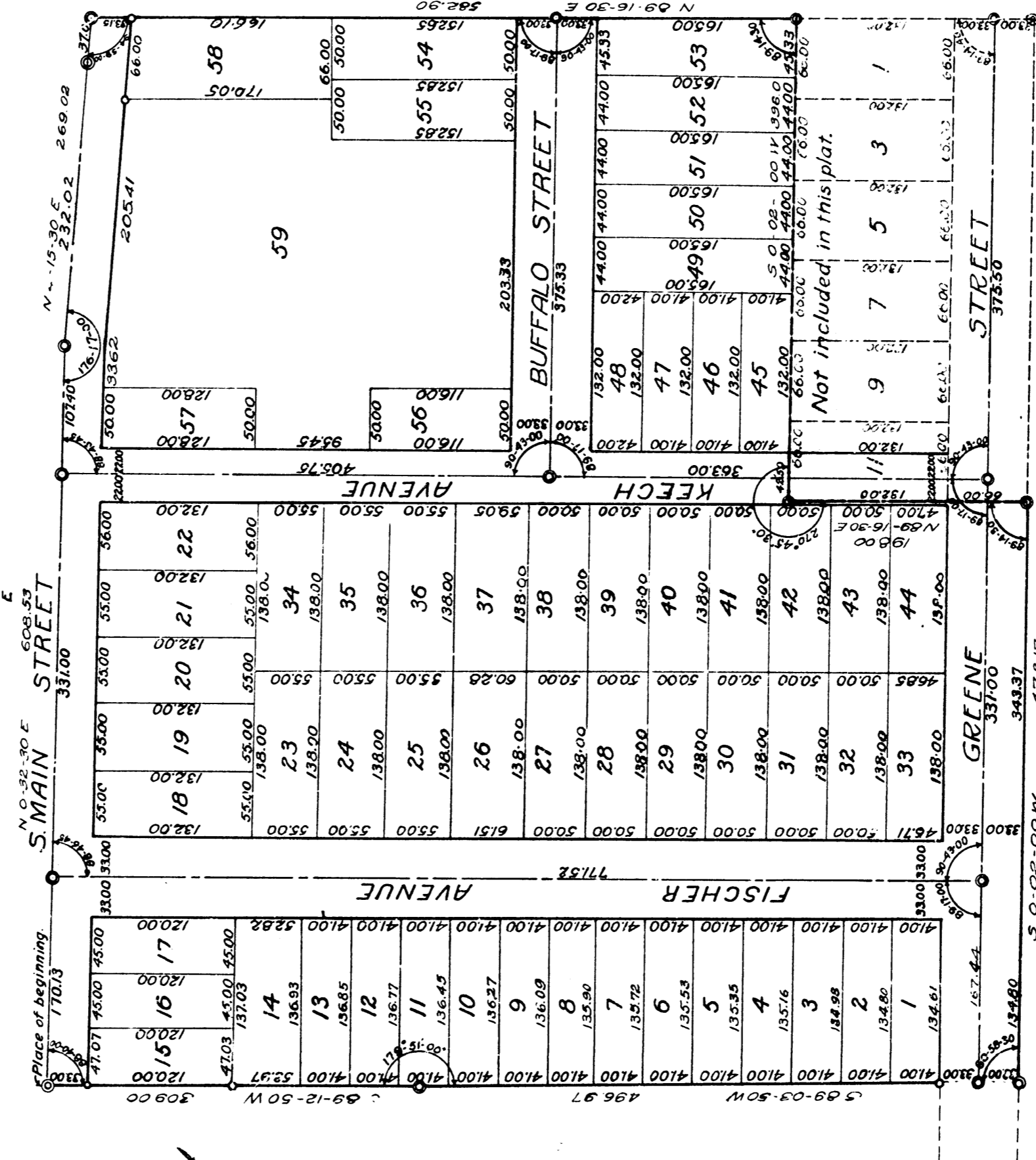
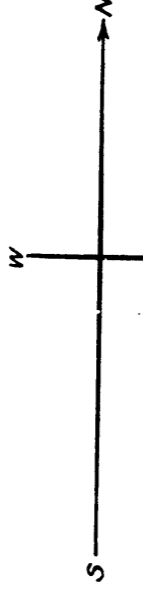


**PLAT OF

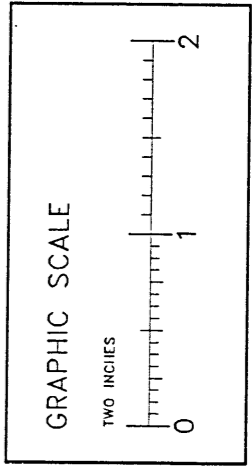

Allmendinger's Addition Thence S. 0° 02' 00" W. 396.00 ft. Thence N. 89° 16' 30" E. 476.17 ft. thence S. 89° 12' 50" W. 309.00 ft. to place of beginning. Being a part of the N.E. quarter of Section number thirty-two, Town two south, Range six east, Washtenaw County, Michigan.
