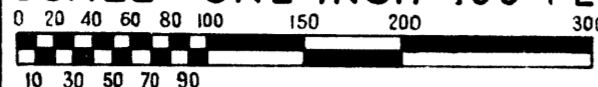


GREEN BRIER SUBDIVISION

CITY OF ANN ARBOR, WASHTENAW COUNTY, MICHIGAN.

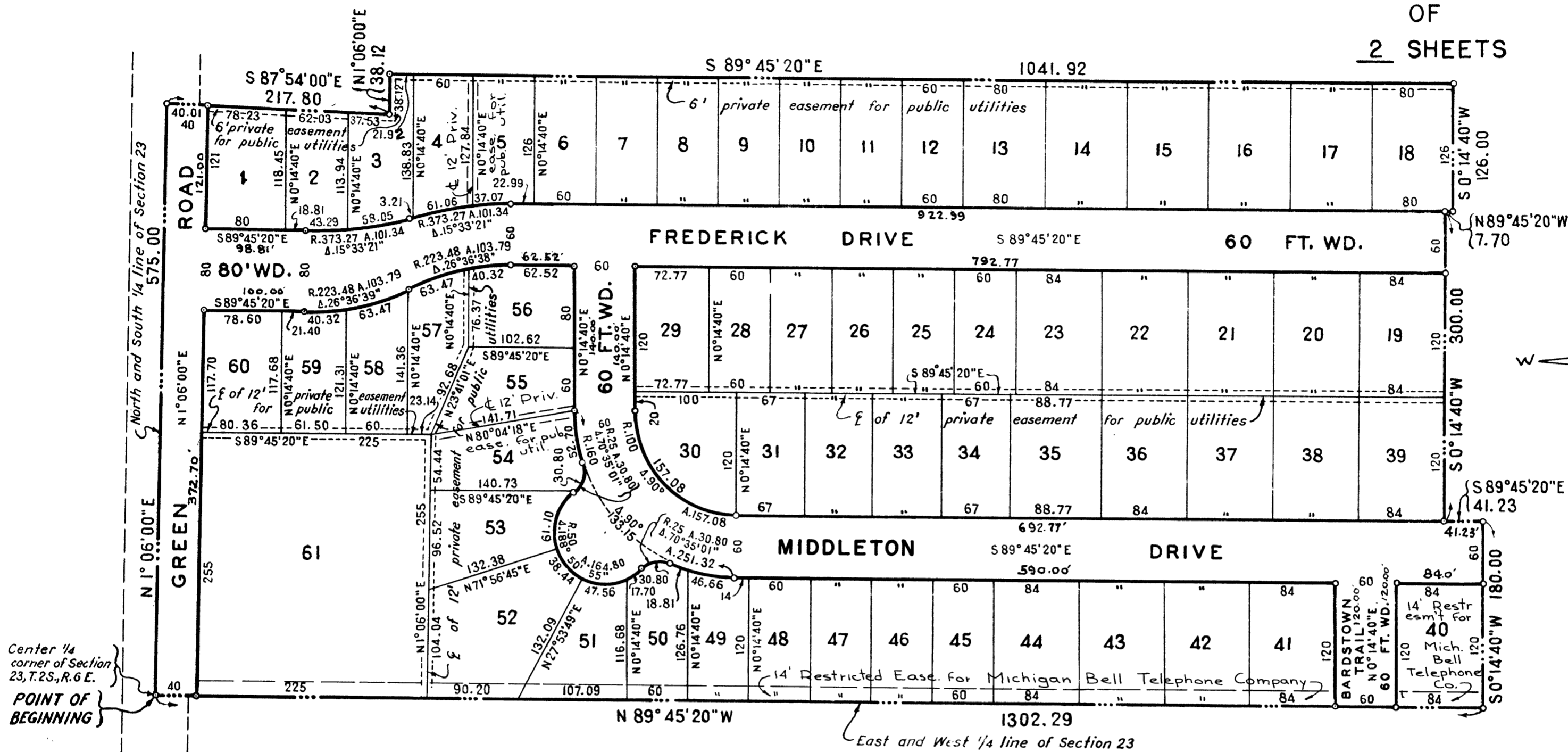

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of Green Brier Subdivision of part of the N.E. 1/4 of Section 23, T.2S., R.6E., City of Ann Arbor, Washtenaw County, Michigan, comprises lots 1 thru 61, inclusive, and is described as follows:

Beginning at the center 1/4 corner of Section 23, T.2S., R.6E., and proceeding N 1° 06' 00" E 575.00 feet along the north and south 1/4 line of said Section 23 coincident with the centerline of Green Road, thence S 87° 54' 00" E 217.80 feet, thence N 1° 06' 00" E 38.12 feet, thence S 89° 45' 20" E 1041.92 feet, thence S 0° 14' 40" W 126.00 feet, thence N 89° 45' 20" W 7.70 feet, thence S 0° 14' 40" W 300.00 feet, thence S 89° 45' 20" E 41.23 feet, thence S 0° 14' 40" W 180.00 feet, thence N 89° 45' 20" W 1302.29 feet along the east and west 1/4 line of said Section 23 to the point of beginning.

SURVEYOR'S CERTIFICATE
