

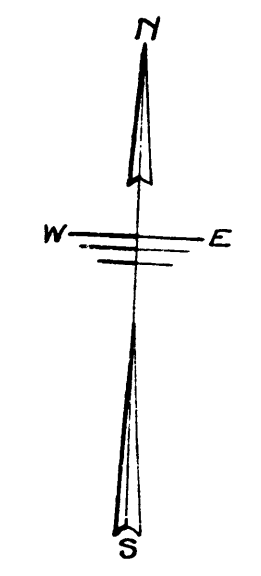

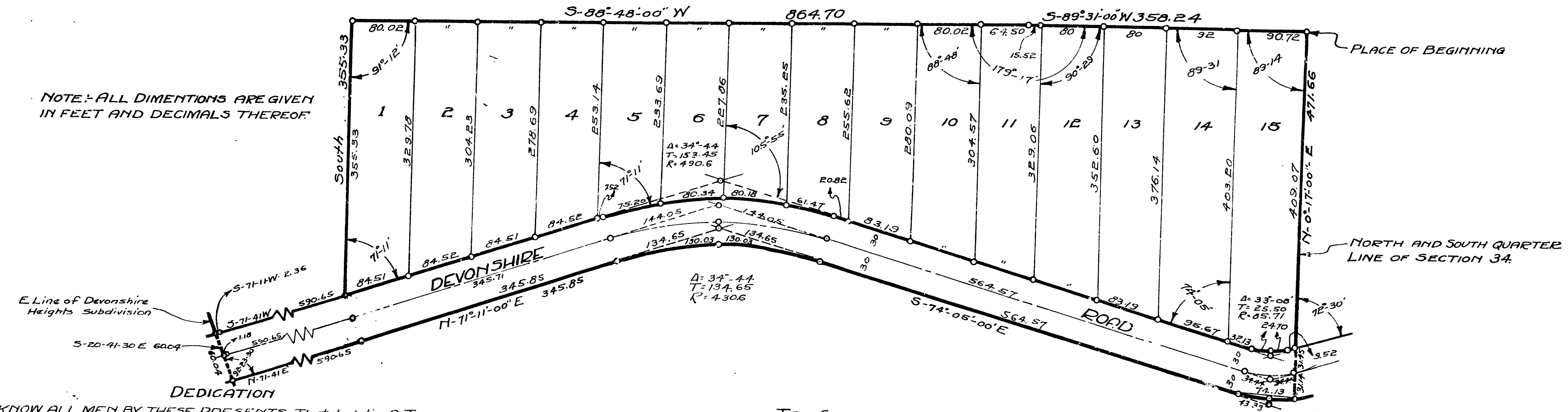
"TUOMY WOODS"

DESCRIPTION.
The land embraced in the annexed plat of "Tuomy Woods," a subdivision of a part of the northwest one-quarter of section 34, Town 2 South, Range 6 East, Washtenaw County, Michigan is described as follows: Commencing at a point on the north and south quarter line of section 34, Town 2 South, Range 6 East Meridian of Michigan, 824.1 feet south of the north quarter post of said section; thence S-89°31'00" W 358.24 feet, deflecting a northwesterly angle of 90°45'00" from the quarter line; thence S-89°48'00" W 864.70 feet; thence south 355.23 feet; thence S-71°41'00" W 590.65 feet; thence S-71°11'00" W 2.36 feet; thence S-20°41'30" E 600.4 feet, said line being a part of the east line of Devonshire Heights Subdivision; thence S-71°41'00" E 590.65 feet; thence N 71°11'00" E 345.85 feet; thence along the arc of a circular curve to the right of radius 430.6 feet, thru a central angle of 34°44'00" to the point of tangency of said curve, the chord of said arc deflecting 17°22' to the right; thence S-74°06'00" E 564.57 feet; thence along the arc of a circular curve to the left of radius 145.71 feet, thru a central angle of 29°26', the chord of said arc deflecting 4°43' to the left and being 74.13 feet to the north and south quarter line; thence N-0°17'00" E 471.66 feet along said quarter line to the place of beginning.
